Ambulance District: The new director Henry Smitley for the ambulance district was in attendance this evening. He came to introduce himself and to tell us a little about what the ambulance district is doing.

- On September 18 from 8-12 they will be doing an active shooter training
- The coverage in Huntington will be up to 90% 7 days a week
- They will not be holding back a mutual aid truck
- There is new software that should be coming to the department.
- 8-12 on Wednesday there will be blood pressure screening.
- CPR training – third Monday of every month watch for information on Facebook.
